

Only the abstracts accepted by the Scientific Committee will be considered. The Evaluation Committee will select 10 applications on the basis of scientific excellence with a preference for students from countries with low GDP per capita.

Recipients of the EAPR support will be required to write a short report about their participation in the EAPR2022 conference by 31st July 2022. Expenses will be reimbursed after the Conference on the basis of the report, proof of payment and invoices.

2022 EAPR COUNCIL MEETING

The EAPR Council meeting took place online on 20th January 2022.

After passing the minutes, the meeting began with a detailed discussion on a draft of the new bylaws needed for associations to function within Belgium (the current home of the EAPR). Kürt (our Vice President) has put considerable effort into this and is now at a stage where it can go to lawyers for finalisation. Part of the bylaws includes more regular meetings with the General Assembly of the EAPR, which will be discussed at the next General Assembly meeting.

Membership is stable at around 200 people, and our finances are looking healthy despite the pandemic - allowing us to support applications from students to attend the Triennial.

Our journal Potato Research is going from strength to strength. The 2021 volume is our largest to date, while the IF has increased to a very respectable 2.07! John Bradshaw, who has acted as Co-ordination Editor for many years, has recently retired from the journal and the Council thanked him for this dedicated

service. This means we are now looking to fill this position so, if you are keen to take part, please get in touch with Paul Struik, our Editor-in-Chief (see page 6).

Section meetings have sadly been on hold during the pandemic but there are now some plans to hold these meetings in the future. At the same time, nominees for the Section leads will be ratified at the General Assembly meeting, together with new councillors and the future President Elect, so come and join us and have your say. For more on this see page 8.

Finally, the Triennial in Kraków was discussed and we are very excited that it is to go ahead in person. Also, plans for the next Triennial in Norway in 2024 are already underway!




SECTION MEETINGS UPDATE

Breeding and Varietal Assessment: Due to the pandemic all Section meetings have been on hold. However, the Breeding and Varietal Assessment Section, which has suffered 2 years of delays, is now planned to take place with the EUCARPIA Potatoes meeting in summer 2023 in the beautiful city of Nigde in Turkey. Nigde is a historical city located in the Cappadocia region of Central Anatolia, and hosts many historical monuments and natural attractions. The province is also the centre of potato production in Turkey.

UPDATING THE EAPR BYELAWS

We are preparing to update the byelaws of EAPR. EAPR is an international association with its siege located in Belgium and must follow Belgian law on associations. The legislation on Associations was updated in 2019 (Belgian companies and associations Code of March 23, 2019), so all associations in Belgium need to update their byelaws by 2024 to meet the new law. Within the new legislation, rules are stricter and associations are treated more like companies.

An important consideration for EAPR is that we should have a General Assembly every year and that the budget and balance should be approved annually. Until now EAPR has its General Assembly every 3 years during the Triennial conference. The option to hold an online General Assembly will be incorporated into the new statutes, to enable us to comply with the legal provisions. As soon as an approved draft by the Council is available, it will be submitted to the General Assembly for a vote.

POTATO RESEARCH

2021 was a very successful year for the journal, with 143 papers submitted, 45 accepted and with others still out for review. The 2021 volume is our biggest yet with 43 paper, 774 pages and 27 papers on line not yet assigned to an issue. What's more, our impact factor has increased to 2.07!

We are an international journal, this year having receiving manuscripts from 23 countries, including Europe (15), Africa (5), Asia (19) and South America (4).



POTATOES IN LATVIA

The potato production area in Latvia is about 18 thousand hectares (2020), which provides 95% of the country's potato consumption. The country is proud of two potato processing companies: Aloja Starkelsen is the largest potato starch producer in the Baltic states, and one of the largest organic potato starch producers globally. Plant Adazu Cipsi produces chips and other salty snacks from potatoes, which are distributed both in Latvia and elsewhere.

New potato varieties have been devel-

oped in Latvia for more than 100 years at the Institute of Agricultural Resources and Economics in Priekuli.

Potato dishes are very popular among the Latvian population, where escaping potatoes (who would want to?) is simply not possible!

Currently available on more than 490 Springer Nature journals, the service has been enthusiastically received by many authors to date. Authors submitting to *Potato Research* will have the choice of submitting their preprint to *In Review* automatically and simultaneously when submitting their manuscript to the journal. The service allows authors to showcase their work to funders and others with a citable preprint while it is under review, indicate the quality control screening undertaken on their work, engage the wider community in discussion to improve their article, and benefit from early sharing, such as more collaboration opportunities and earlier citations.

where readers are able to view all the preprints currently under consideration at the journal. The development team at Springer Nature is already working on adding *In Review* to *Potato Research*, so please be sure to keep an eye out for the dedicated *In Review* page for the journal soon!



PSTV found in potential trap crop

Potato spindle tuber viroid has been detected by Fera Science Ltd in *Solanum sisymbriifolium* seed in trade. The plant is used as a trap crop to control PCN and may therefore offer the potential for transmission of the virus to potato. The work is reported in New Disease Reports.
